The Board of Directors of Paseo del Este Municipal Utility District No. 4 (the "District") held a regular meeting, open to the public, at 110 Mesa Park Drive, Suite 200, El Paso, Texas 79912, one of the regular meeting places of the Board, on Friday, November 15, 2019, and the roll was called of the directors of the Board, to-wit:

and all said persons were continuously present, thus constituting a quorum.

Also present were Ronald J. Freeman and Cyndi Ferris of the Law Offices of Ronald J. Freeman (by telephone); Lourdes González of INFRAMARK; Nadia Ganser of TRE & Associates, LLC; and Taylor Kolmodin and Tyler Wilson of Municipal Accounts & Consulting, L.P. (by telephone). Ms. Kolmodin entered the meeting as noted below.

1. The Board first considered approval of the minutes of the Board's October 11, 2019, meeting. Director Jackson made a motion to approve the minutes. Director Rodriguez seconded the motion, which the Board passed unanimously.

2. As its next item of business, the Board considered the General Manager's and Operator's Reports. Ms. González presented a report on the status of development in the District and other districts. No action was taken by the Board. Ms. Kolmodin entered the meeting during discussion of this item.

3. The Board then considered approving payment of bills and invoices and the financial report. After discussion, Director Jackson made a motion to approve: (i) the payment of bills and invoices listed in the report (Check Nos. 1295-1304); and (ii) Supplemental Check No. 1305 in the amount of \$2,316.60 payable to Municipal Accounts & Consulting. Director Romero seconded the motion, which the Board passed unanimously. A copy of the Bookkeeper's Report is attached to these minutes.

4. The Board next considered the Developer's Report. Mr. Stubbs gave a brief report. No action was taken by the Board.

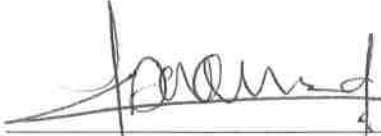
