- 1. The Board first considered approval of the minutes of the Board's October 10, 2019, meeting. Director Ulrich made a motion to approve the minutes. Director Garnica seconded the motion, which the Board passed unanimously.
- 2. As its next item of business, the Board considered the General Manager's and Operator's Reports. Ms. González gave a brief report on the status of development in the District and other districts. No action was taken by the Board.
- 3. The Board then considered approving payment of bills and invoices and the financial report. Ms. Kolmodin presented the financial report for the District along with bills and invoices. After discussion, Director Hansen made a motion to approve the payment of bills and invoices as listed in the report (Check Nos. 4530-4540). Director Moye seconded the motion, which the Board passed unanimously. A copy of the Bookkeeper's Report is attached to these minutes.

The Board next considered the Report on the Application of Certain Agreed Procedures ("AUP Report") for developer reimbursement in relation to District's Use of \$496,294 Surplus Series 2019 Bond Funds and Maintenance Tax Revenues. Mr. West gave a brief report. Upon a motion by Director Moye and a second by Director Ulrich, the Board unanimously approved the AUP Report.
- 5. The Board then considered the Developer's Report. Mr. Stubbs gave a brief report on the status of development in the Paseo del Este MUDs. No action was taken by the Board.

6. As its final act of business, the Board considered the Engineer's Report. Ms. Ganser gave a brief report. No action was taken by the Board.
