and all said persons were continuously present except Directors Quiñones and Contreras, thus constituting a quorum.

Also present were Lourdes González of INFRAMARK; Linda Troncoso of TRE & Associates, LLC; Bob West of West Davis & Company, LLP; Franklin Stubbs of Hunt Communities; and Nur Labardini of Municipal Accounts & Consulting, L.P. (by telephone).

- 1. The Board first considered approval of the minutes of the Board's December 13, 2019, meeting. Director Silva made a motion to approve the minutes. Director Touchstone seconded the motion, which the Board passed unanimously.
- 2. As its next item of business, the Board considered the Texas Water Code Chapter 49 petition process to establish a meeting place within the District's boundaries. No action was taken by the Board.
- 3. The Board then considered the General Manager's and Operator's Reports. Ms. González gave a brief report on the status of development in the District and other districts. No action was taken by the Board.
- 4. The Board next considered approving payment of bills and invoices and the financial report. Ms. Labardini presented the financial report for the District along with bills and invoices. After discussion, Director Silva made a motion to approve (i) the payment of bills and invoices as listed in the report (Check Nos. 4719-4740), except Check Nos. 4731 to Director Contreras and Check No. 4733 to Director Quiñones since they were absent; (ii) Supplemental Check Nos. 4741 in the amount of \$1,658.55 payable to Municipal Accounts & Consulting and Check No. 4742 in the amount of \$8,000.00 payable to West Davis & Company; and (iii) a wire transfer to Hunt Communities in the amount of \$571,056.00. Director Spurlin seconded the motion, which the Board passed unanimously. A copy of the Bookkeeper's Report is attached to these minutes.

- 5. The Board then considered the Report on the Application of Certain Agreed Procedures ("AUP Report") for developer reimbursement in relation to District's Use of \$575,000 Surplus Series 2017A & 2018 Bond Funds and Maintenance Tax Revenues. Mr. West gave a brief report. Upon a motion by Director Touchstone and a second by Director Spurlin, the Board unanimously approved the AUP Report.
- 6. As its next item of business, the Board considered the District's annual financial statements and Auditor's Report. Mr. West gave a brief report. Upon a motion by Director Silva and a second by Director Spurlin, the Board unanimously approved the Financial Statements, Supplemental Information and Independent Auditor's Report for the Year Ended September 30, 2019.
- 7. The Board then considered the Developer's Report. Mr. Stubbs gave a brief report on the status of development in the Paseo del Este MUDs. No action was taken by the Board.
- 8. As its final act of business, the Board considered the Engineer's Report. Ms. Troncoso gave a brief report. No action was taken by the Board.

There being no further business, the meeting was adjourned.
