1. As its first item of business, the Board considered approval of the minutes of the Board’s January 9, 2020, meeting. Director Wheeler made a motion to approve the minutes. Director Romero seconded the motion, which the Board passed unanimously.

2. As its next item of business, the Board considered the General Manager’s and Operator’s Reports. Ms. González presented a report on the status of development in the District and other districts. No action was taken by the Board.

3. The Board then considered approving payment of bills and invoices and the financial report. Ms. Kolmodin presented the financial report for the District along with bills and invoices. After discussion, Director Rico made a motion to approve the payment of bills and invoices as listed in the report (Check Nos. 4478-4489). Director Peterson seconded the motion, which the Board passed unanimously. A copy of the Bookkeeper’s Report is attached to these minutes.

4. The Board next considered the Developer’s Report. Mr. Stubbs gave a brief report on development in the Paseo del Este MUDs. No action was taken by the Board.

5. The Board then considered a Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value. Upon a motion by Director Wheeler and a second by Director Romero, the resolution was unanimously approved by the Board.

6. As its final act of business, the Board considered the Engineer's Report. Ms. Troncoso gave a brief report. No action was taken by the Board.
