If no suitable meeting place exists inside the district, the board may designate a meeting place outside the district that is located not further than 10 miles from the boundary of the district. On the failure, after a request is made of the board to designate the location of the meeting place within the district or not further than 10 miles from the boundary of the district, five electors may petition the Texas Commission on Environmental Quality ("the TCEQ") to designate a location. If the TCEQ determines that the meeting place used by the district deprives the residents of a reasonable opportunity to attend district meetings, the TCEQ shall designate a meeting place inside or outside the district which is reasonably available to the public and require that the meetings be held at such place.

- 6. Receive report from Paseo del Este MUD No. 1 regarding Master District activities.
- 7. Consider and take action regarding General Manager's and Operator's Report.
- 8. Consider and take action regarding Bookkeeper's Report, bills and invoices, investments and other financial management matters.
- 9. Consider and take action regarding approval of annual financial statements and audit report.
- 10. Consider and take action regarding Developer's Report.
