- 1. The Board first considered approval of the minutes of the Board's December 8, 2022, regular meeting. Director Ulrich made a motion to approve the minutes. Director Hansen seconded the motion, which the Board passed unanimously.
- 2. As its next item of business, the Board considered Texas law regarding District meeting places. No action was taken by the Board.
- 3. The Board then received a report from the Paseo del Este MUD No. 1 regarding Master District activities. Ms. Livingston provided a report on the Master District activities. No action was taken by the Board.
- 4. The Board next considered the General Manager's and Operator's Report. Ms. Duran gave a report summarizing the status of development in the District and other districts. No action was taken by the Board.

- 5. The Board then considered approving payment of bills, invoices and the financial report. Mr. Wilson presented the financial report for the District along with bills and invoices. After discussion, Director Ulrich made a motion to approve the (i) payment of bills and invoices as listed in the report (Check Nos. 4912-4925); and (ii) Supplemental Check No. 4926 in the amount of \$3,257.73 payable to Municipal Accounts & Consulting, L.P. Director Moye seconded the motion, which the Board passed unanimously. A copy of the Bookkeeper's Report is attached to these minutes.
- 6. The Board next considered the District's annual financial statements and Auditor's report. Mr. West gave a brief report. Upon a motion made by Director Moye and a second by Director Hansen, the Board unanimously approved the Financial Statements Supplemental Information and Independent Auditor's Report for the Year Ended September 30, 2022.
- 7. The Board then considered the Developer's Report. Mr. Stubbs gave a brief report on development within the District. No action was taken by the Board.
- 8. As its final act of business, the Board considered the Engineer's Report. Mr. Ortiz provided updates on the development and construction within the District. He then provided updates on the rehabilitation of ponds within the Paseo del Este MUDs. No action was taken by the Board.
