We, the undersigned, constituting a majority of the members of the Board of Directors of the referenced District do hereby make and execute this Amendment No. 9 to Information Form in compliance with Section 49.455, Texas Water Code, as amended. We do hereby certify as follows:

1. The total amount of bonds that have been approved by the voters and which may be issued by the District (excluding refunding bonds and any bonds or portion of bonds payable solely from revenues received or expected to be received pursuant to a contract with a governmental entity) is \$17,000,000.00.


2. The aggregate initial principal amount of all bonds of the District payable in whole or in part from taxes (excluding refunding bonds and any bonds or portion of bonds payable solely from revenues received or expected to be received pursuant to a contract with a governmental entity) that have been previously issued is \$9,540,000.00.

3. The most recent tax rate of taxes levied by the District on real property located in the District is \$0.7339 on each \$100 of assessed valuation.


4. The Notice to Purchaser required by Section 49.452, Texas Water Code, is attached as **Exhibit "A"**

5. The legal description and map showing the boundaries of the District, required by Section 49.455, Texas Water Code, is attached as **Exhibit "1"**.



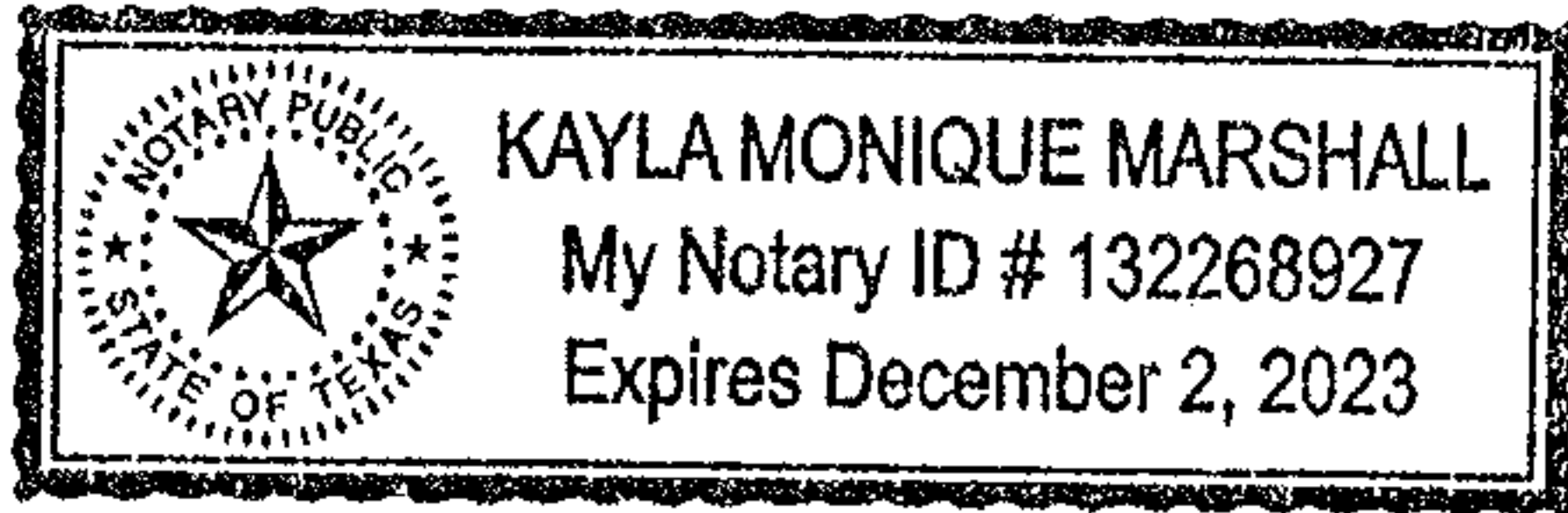

NOTICE TO PURCHASER

The real property, described below, that you are about to purchase is located in Paseo del Este Municipal Utility District No. 2. The district has taxing authority separate from any other taxing authority and may, subject to voter approval, issue an unlimited amount of bonds and levy an unlimited rate of tax in payment of such bonds. As of this date, the rate of taxes levied by the district on real property located in the district is \$0.7339 on each \$100 of assessed valuation. The total amount of bonds, excluding refunding bonds and any bonds or any portion of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters and which have been or may, at this date, be issued is \$17,000,000.00, and the aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the district and payable in whole or in part from property taxes is \$9,540,000.00.

The district has the authority to adopt and impose a standby fee on property in the district that has water, sanitary sewer, or drainage facilities and services available but not connected and which does not have a house, building, or other improvement located thereon and does not substantially utilize the utility capacity available to the property. The district may exercise the authority without holding an election on the matter. As of this date, the most recent amount of the standby fee is \$0.00. An unpaid standby fee is a personal obligation of the person that owned the property at the time of imposition and is secured by a lien on the property. Any person may request a certificate from the district stating the amount, if any, of unpaid standby fees on a tract of property in the district.

The district is located in whole or in part in the extraterritorial jurisdiction of the City of El Paso. By law, a district located in the extraterritorial jurisdiction of a municipality may be annexed without the consent of the district or the voters of the district. When a district is annexed, the district is dissolved.

The purpose of this district is to provide water, sewer, drainage, or flood control facilities and services within the district through the issuance of bonds payable in whole or in part from property taxes. The cost of these utility facilities is not included in the purchaser price of your property, and these utility facilities are owned or to be owned by the district. THE DISTRICT ROUTINELY ESTABLISHES TAX RATES DURING THE MONTHS OF SEPTEMBER THROUGH DECEMBER OF EACH YEAR, EFFECTIVE FOR THE YEAR IN WHICH THE TAX RATES ARE APPROVED BY THE DISTRICT. PURCHASER IS ADVISED TO CONTACT THE DISTRICT TO DETERMINE THE STATUS OF ANY CURRENT OR PROPOSED CHANGES TO THE INFORMATION SHOWN ON THIS FORM.

FIELD NOTES DESCRIBING 380.518 acres of land, being a portion of Section 315 ½, W. J. Rand Survey, a portion of Section 319, C. D. Stewart Survey, and a portion of Section 18, Block 79, Township 3, Texas and Pacific Railway Company Survey, situated in El Paso County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at the Northwest corner of said Section 315 ½, being the common corner of said Section 315 ½, Section 17, Block 79, Township 3, Texas and Pacific Railway Company Survey, and Sections 312 and 315, O. A. Danielson Survey, for the Northwest corner and POINT OF BEGINNING of this tract.

THENCE with the division line between said Sections 17 and 315 ½, East, 5318.17 feet to the common corner of said Sections 315 ½, 319, 17 and 18, for an ell corner of this tract.

THENCE with the division line between said Sections 315 ½ and 319, South, 44.55 feet to an angle point of this tract.

THENCE with the arc of said curve 1854.00 feet, the long chord of which bears N41°49'51"W, 1648.39 feet to the Point of Tangency of said curve.

THENCE N89°22'51"W, 228.77 feet to the Point of Curvature of a curve to the right having a radius of 2000.00 feet and a central angle of 2°38'18".

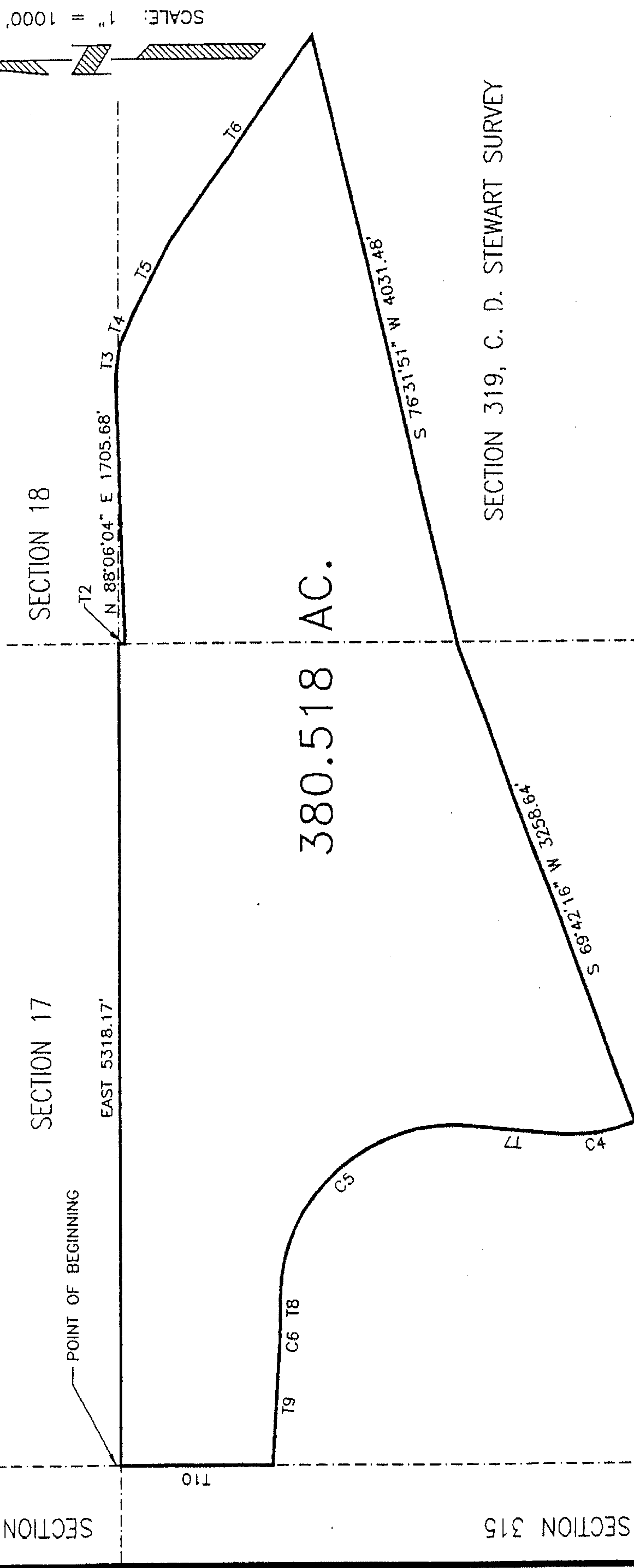
THENCE with the arc of said curve 92.09 feet, the long chord of which bears N88°03'42"W, 92.08 feet to the Point of Tangency of said curve.

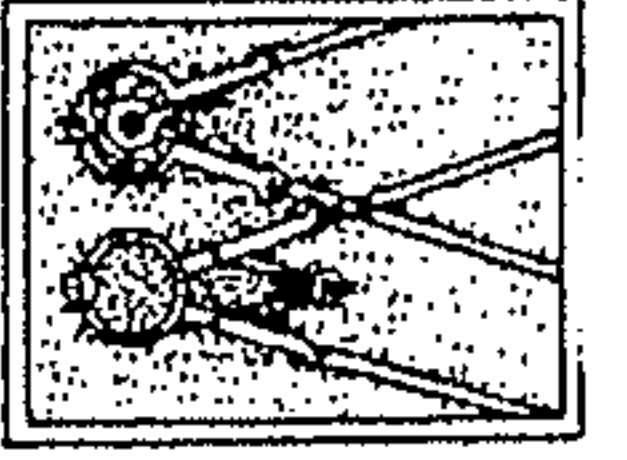
